Intimation under Regulation 30(4) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Proposed Strike in the Bank on Wednesday, the 30th of March, 2022 and Thursday, the 31st of March, 2022.

This is to inform you that United Forum of Bank Unions (UFBU) has given notice that members of all the constituent unions of UFBU propose to go on strike on Wednesday, the 30th of March, 2022 and Thursday, the 31st of March, 2022, demanding resolution of several issues.

In case the proposed strike materialises, employees and officers of the Bank belonging to the constituent unions of UFBU in the Bank, may partake in the same which may affect the normal functioning of the branches/ offices of the Bank at a minimum level, as only less than 25% of the total work force of the Bank is affiliated to various unions. Please note that the alternative banking channels will continue to function normally.
