- 2) To the best of knowledge and information of BANK, there is no encumbrance on the property. The property is being sold with all the existing and future encumbrance whether known or unknown to the bank. BANK shall not be responsible in any way for any third party claims/right/dues.
- 3) The old building situated in the property with Door nos. CC-5/3478 to 3488 are under orders of demolition vide directions issued by Cochin Corporation as per Letter dated 11.09.2023 and the successful bidder is bound to comply with the said directions without fail.
