The voting rights shall be as per the number of equity shares (physical or in dematerialised form) held by the Member(s) as on **14**th **March 2018 (Cut-off Date)**. Members are eligible to cast vote electronically or at the meeting venue (physical or venue e-voting), only if they are holding shares as on the Cut-off date.

In case any person becoming a member of the Bank after the dispatch of the EGM notice but before the cut-off date, i.e. March 14, 2018, he/she may write to the Bank's Registrars & Share Transfer Agents, SKDC Consultants Limited through email at info@skdc-consultants.com for obtaining the login ID and password for remote e-voting. In case, if a person is already registered with CDSL for e-voting, then existing user ID and password can be used for casting their vote. If any person who is not a member/ceased to be a member as on the cut-off date should treat this notice for information purpose only.

Members who have not cast their vote by remote e-voting can exercise their voting rights at the EGM through physical ballot/Venue e-voting. The Bank will make necessary arrangements in this regard at the venue of the EGM.

Members may participate in the EGM even after exercising their right to vote through remote evoting but shall not be entitled to vote again at the EGM.
